Dear Snowmass Village resident,

Snowmass Village residents may obtain their Winter 2024-2025 parking permits by mail. Permitted parking for the numbered lots begins on Thursday, November 28, 2024. Please provide the information requested on the enclosed form along with required items as listed:

- PERMIT APPLICATION detailing a maximum of 3 permits.
- PAYMENT by check for the total cost of all permits made payable to "TOSV."
DO NOT SEND CASH
- PROOF OF RESIDENCY. If your name is listed on the county tax rolls as a Snowmass Village property owner as of September 30, 2024, no other proof is required. If your property is not listed in your name or varies from the name on the parking application (i.e. listed under an LLC/partnership or recently acquired), please explain and attach copies of ownership evidence, e.g. a partnership agreement.
- COPY OF CURRENT VEHICLE REGISTRATION(S). Annually, a copy of the **current** vehicle registration that is in your name must be attached for each vehicle to be permitted. If you sell your vehicle or replace your license plate, please notify us immediately.
- Payment receipt will be sent to your email address and your license plate will then serve as your valid permit number. Only enclose a self-addressed, stamped envelope if you would like a mailed receipt.

Proof of residence and vehicle registration must be verified annually. Applications that are incomplete or have payment errors will not be processed. We will attempt to contact you by email from parking@tosv.com if your application or payment is incomplete.

I hope our permit mailing proves convenient for you. If you prefer to make an in-person purchase, please bring the items listed above to our office located at 51 Elbert Lane one level above the mall after October 1, 2024.

IT IS INCUMBENT UPON YOU TO KNOW WHICH VEHICLE(S) ARE PERMITTED FOR WHICH PARKING LOTS.

PERMITTED VEHICLES MUST ADHERE TO POSTED TIMED PARKING RESTRICTIONS IN DESIGNATED LOTS. PERMITTED VEHICLES MAY NOT PARK IN AREAS POSTED AS "PRIVATE PARKING" OR POSTED FOR BUSINESS OWNER/MERCHANT PARKING.

PREMIUM RESIDENT 1, 2 OR 3 PERMITTED VEHICLES MAY PARK IN LOTS **1 - LOWER 5, 8 - 13** AND THE **DIVIDE LOT.**

RESTRICTED RESIDENT PERMITTED VEHICLES MAY ONLY PARK IN LOTS **10 - 13** ONLY.

VEHICLES PARKED IN LOTS 1 - 13 MUST BE MOVED AT LEAST EVERY FOUR DAYS OR FOLLOWING A SNOWSTORM. VEHICLES NOT IN COMPLIANCE WILL BE SUBJECT TO TICKET AND TOW.

ANY PERSON PROVEN TO HAVE **FALSIFIED INFORMATION** ON THE PERMIT APPLICATION OR IMPROPERLY TRANSFERRED A LICENSE PLATE WILL BE SUBJECT TO A \$300 FINE AND STATE LAW.

ALL PERMITTED VEHICLES MUST BE REGISTERED IN COMPLIANCE WITH THE COLORADO STATE LAW.
